GENERAL INFORMATION

ALL VENDORS PURCHASING A BOOTH TO THIS EVENT MUST AGREE TO THE FOLLOWING CONDITIONS:

1. The festival committee has the discretion to relocate a vendor if deemed necessary and maintain control over the booth spaces for the duration of the festival.
2. One (1) table and two (2) chairs will be provided to each vendor purchasing a booth. Additional tables and chairs may be rented for an extra fee.
3. Vendors are responsible for all items necessary to display their goods. This includes showcases, lights, tablecloths, extension cords for electricity etc.
4. The church will not [provide credit card verification services.
5. Vendors may begin setting up on Thursday, June 9, 2022 at 12 noon. Vendors are responsible for timely set-up and breakdown of their spaces.
6. Vendor Mandatory Open Hours-no exceptions (rain or shine)

7. Vendors MUST be cleared out of their area by 11:00 pm on Sunday June 12, 2022.
8. Vendors are responsible to maintain a clean and debris free environment in and around their booth space.
9. Vendors are responsible for all business transactions and manning their booths, securing their cash etc.
10. Each vendor is required to provide signage for their area occupied indicating their trade name.
11. Security:
12. The church is not an insurer and shall not be liable for any theft, loss or other casualty to any vendors equipment, merchandise, or currency. The church will not be liable damages whatsoever resulting from your occupancy of the leased space, including personal injury and property damage. Vendors must obtain insurance coverage for their personal items and goods.
13. Vendors must leave the space free of any and all debris on Sunday, June 12, 2022.
